PROGRAM PURPOSE

Emergency medical services is a program designed to meet the needs for well-trained EMTs and paramedics. The program follows the National Emergency Medical Services Education Standards for Paramedic Education and meets or exceeds the national standards for minimum clinical, didactic, lab and field externship hours and competencies. The program is offered with ongoing approval from Maine Emergency Medical Services, is accredited by the Commission on Accreditation of Allied Health Professions (CAAHEP), and follows the standards and guidelines of the Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions (CoAEMSP). The core courses will simulate EMT and paramedic preparations, including studies of cardiac emergencies, emergency resuscitation, medical/legal issues, pharmacology, psychological emergencies, trauma, obstetrics and gynecology, pediatrics, and neonatal care. In the hospital clinical component, students will observe, assess, and assist with care of medical, surgical and trauma patients; will administer medications; and will assist with diagnostic procedures. Clinical experiences will occur in pediatric, labor and delivery, emergency department, and critical care settings. Field experiences will allow the student to take the team leadership role.

Students receive real experience at externships in their first year!

Graduates from the associate degree EMS program are prepared for rewarding careers with:

APPLICATION PROCEDURE

The following procedures constitute the admissions process:

- 1. Submit an NMCC application along with a \$20 application fee.
- Submit offical high school transcript and/ or HiSET/GED scores (current senior's transcript should include completed ranking period grades).
- 3. Official college transcripts for applicants who have attended other post-secondary schools.
- 4. If SAT scores are not available, placement testing will be required.
- 5. Individual interview required. A campus tour is highly recommended.
- 6. Applicants must be at least 18 years of age.

Note: Criminal history record search will be completed by NMCC personnel. Prior criminal convictions may preclude program admission or licensure.

NOTE: Whether admitted into the associate degree program or just taking an EMS course, all students are required to meet certain admission requirements including proof of immunizations.

- To be eligible for national AEMT and/or Paramedic certification, a cumulative average grade of '80', (B-) in all major EMS courses is required.
- Applicants who have not successfully completed (73 or higher)
 ALH 124 within the past 12 months are required to take the course and/ or demonstrate competency through work experience.
- Not all courses are offered every semester.
- Clinical externships are faculty directed courses; students work with an assigned preceptor in various clinical rotations in both the hospital and prehospital setting.
- Students are responsible for the additional cost of Advanced Cardiac Life Support, Neonatal Resuscitation, Pediatric Advanced Life Support, Prehospital Trauma Life Support and travel expenses associated with the urban externship. These courses are required to attain Paramedic Certification.
- Students wishing to use their financial aid for summer semester courses must indicate such on their financial aid application.
