Northern Maine Community College is currently requesting proposals for assistance with the snow removal for the 18-19, 19-20, and 20-21 winter seasons. The initial contract period will be for 3 years and may be extended, at the discretion of the College, for two additional one year terms for a total maximum of 5 years. The College is seeking pricing for snow removal from sidewalks, stairs, and building entrances. Salt entrances to 50 feet from building with concrete and landscape safe salt, sand sidewalks more than 50 feet from building. Please see the attached map for details on the areas for which the selected vendor will be responsible. All snow removal must be completed for the selected areas by 6:30am. Vendor shall coordinate with NMCC staff and other snow removal vendors to ensure the campus snow removal has been completed to the satisfaction of NMCC.

Proposals shall detail an hourly cost for labor and equipment, cost per trip, vendors must clearly define parameters for a trip, and describe considerations for trips per storm. Proposals shall also include company information such as equipment that will be used, number of employees, and references on past contracts of similar size and scope.

- 5. Add any entity as an additional insured to MCCS policies of insurance;
- 6. Pay attorneys' fees, costs, expenses or liquidated damages;
- 7. Promise confidentiality in a manner contrary to Maine's Freedom of Access Act;
- 8. Permit an entity to change unilaterally any term or condition once the contract is signed; and
- 9. Automatic renewals for term(s) greater than month-to-month.

By submitting a response to a Request for Proposal, bid or other offer to do business with MCCS, <u>YOUR</u> <u>ENTITY UNDERSTANDS AND AGREES THAT</u>:
