PROGRAM PURPOSE

The Community Paramedicine program is designed to educate practicing paramedics, primarily employed in the pre-hospital emergency environment to become competent community paramedics. Community paramedics work collaboratively with public health, home care and primary care professionals in non-emergency settings, filling gaps in the healthcare workforce. Community paramedics help patients meet critical health needs by assisting in establishing health systems that promote health and wellness, while serving as advocates, educators, facilitators, liaisons, and resource coordinators. The program is designed to allow paramedics to perform needs assessments and assist in the development of community paramedicine initiatives that meet very specific and individualized community needs.

Paramedics with an academic credential (associate degree or higher, in any field) may enroll directly into the advanced certificate level of the program; those candidates who have not yet earned an associate degree will be considered for the Associate Degree in Science level of the program.

APPLICATION PROCEDURE

The following procedures constitute the admissions process:

- 1. Submit an NMCC application along with a \$20 application fee.
- Submit official high school transcript and/or HiSET/GED scores (current senior's transcript should include completed ranking period grades).
- 3. Official college transcripts for applicants who have attended other post-secondary schools.
- 4. If SAT scores are not available, placement testing may be required.
- 5. Individual interview required.
- 6. A campus tour is highly recommended.
- 7. Submit a copy of applicant's NREMT certification or state/provinicial license.

Note: Criminal history record search will be completed by NMCC personnel. Prior criminal convictions may preclude program admission or licensure.

Note: All students are required to meet certain admission requirements, including proof of immunization.

Please note that the Advanced Certificate program is only available for those who already possess, at minimum, an associate degree.

PLEASE NOTE:

- Candidates for admission must present at least one of the following: an active paramedic license or Advanced Care Paramedic license (Canada), proof of equivalent licensure from another state, or NREMT registration at the Paramedic level.
- EMS 245 is a faculty directed course, students work with an assigned preceptor in various clinical rotations in both the hospital and community settings.
- The clinical coordinator for EMS 245 will make every attempt to have clinical agreements within reasonable proximity of the student's home location.
- Applicants who have not successfully completed (73 or higher) ALH 124 within the past 12 months are required to take the course and/or demonstrate competency through work experience.
- A list of suggested courses to complete elective requirements will be provided to students.
- EMS 246 is provided entirely on-line.
 - Major courses; a minimum grade of "C" or 2.0 required.
 Community Paramedicine Major Courses; require a minimum grade of '77' or (C+)
