## **APPLICATION PROCEDURE**

The following procedures constitute the admissions process:

- 1. Submit an NMCC application
- Submit official high school transcript and/or HiSET/GED scores (current senior's transcript should include completed ranking period grades)
- 3. Official college transcripts for applicants who have attended other post-secondary schools
- 4. Two confidential recommendations from *professional or academic sources*
- 5. Supplemental Questionnaire
- 6. Personal interview with the Nursing Admissions committee
- 7. TEAS Test of Essential Academic Skills
- 8. A campus tour is highly recommended

Note: Criminal history record search will be completed by NMCC personnel. Prior criminal convictions may preclude program admission or licensure.

# **CAREER OPPORTUNITIES**

Graduates will find employment opportunities as an integral team member in a variety of healthcare settings.

For graduates interested in continuing their education by pursuing a bachelor of science in nursing degree, NMCC has transfer agreements in place with four-year institutions. By completing the first two years at NMCC, students are able to graduate with less debt and are prepared to take advantage of online programs.

## **PROGRAM PURPOSE**

NMCC's nursing program is designed to prepare students to become registered nurses. Students develop the necessary knowledge and skills to provide nursing care in various capacities throughout a patient's lifetime. Guided learning opportunities in local hospitals, the campus lab, and state-of-the-art simulation center provides students with valuable hands-on experiences that complement the classroom curriculum.

Candidates who are graduates from approved nursing programs are provided an opportunity for advanced standing. Students with successful prior college courses may receive priority, providing all other minimum standards are met. Students may be given only one opportunity to reenter the program after having failed to complete it previously.
